## **WEDNESDAY AT 12 NOON: NJ Constituents to Rally in Newark to Urge SENATOR BOOKER to Support Iran Deal**

**Rally is one of more than 200 being held at Congressional offices across the country.**

**MAPLEWOOD, NJ** — On Wednesday, August 26, New Jersey constituents will gather outside the Newark office of Senator Cory Booker to urge him to support the agreement that the United States and other world powers have reached to prevent Iran from obtaining a nuclear weapon. Following the event, the activists will deliver a petition to Senator Booker, signed by more than 15,000 of his constituents, urging Booker to support the agreement.

### **Rally Agenda**

Remarks by rally host, **Paul Surovell**, a MoveOn member from Maplewood, **Madelyn Hoffman**, director of NJ Peace Action, Rutgers professor **Eric Davis**, former chairman of the Rutgers Center for Middle Eastern Studies and an open mic for attendees who wish to speak. The rally will end with several songs by the **Solidarity Singers**, including a new version of "Give Peace A Chance" addressed to Senator Booker.

"This is a crucial time to urge Senator Booker to be a champion for diplomacy and for the Iran nuclear deal, which is supported by former US and Israeli generals and by NATO and by all the major powers of the world," said Paul Surovell of Maplewood, the MoveOn member who is coordinator of the action.

"We are hopeful that Senator Booker will conclude that the deal does not rely on trust, but on verification and that it provides the most intrusive and comprehensive program of inspections and verification measures ever imposed on a country."

"Furthermore, we hope that Senator Booker will conclude that issues of concern about Iran's behavior that are unrelated to nuclear weapons can be addressed as needed, apart from the nuclear agreement and that non-nuclear sanctions against Iran are not affected by the agreement," Surovell said.

"The bottom line is that the Iran nuclear deal achieves peace through strength -- the strength of a united world community and the most comprehensive program of inspections and verification measures ever devised that will remain in place for 25 years and beyond," Surovell said.
